General comments	<ol> <li>Data used in the initial programme rationale is insufficient, selective and outdated. In particular, it fails to reflect the wider humanitarian crisis under which the programme would be delivered (in particular to child malnutrition, maternal mortality and access to essential services including health). It notably omits the social and demographic impact of Venezuela's migration outflows, assuming old official population projections as a valid representation of the situation (UNICEF). In addition, it</li> </ol>	UNICEF welcomes the comments made by the United Kingdom (UK) on the Venezuelan Country Programme Document (CPD). The CPD is aligned with and derived from the UN Sustainable Development Framework signed in September 2022. The description of the humanitarian situation in Venezuela is analysed and addressed within the Humanitarian Response Plan, in which UNICEF has a leading role as Cluster Coordinator of WASH, Nutrition and

only mentions positive GDP growth in 2022 but does not refer to the erosion of nearly 80% of GDP from previous years. It is unlikely that this year's GDP growth rate will be sustained. There is also no mention of domestic drivers affecting macro-economic performance.	Education, and of the Area of Responsibility of Child Protection.
2. Proposed work includes improving State capacity to generate evidence and data, in partnership with ministries and other Government agencies such as the National Statistics Institute (INE) and the National Nutrition Institute. However, efforts should include increasing transparency and access to reliable data in order to support improved diagnostics and evidence-based policy-making. Baseline figures used by UNICEF date back to 2016, 2017 and 2019, when available, which may not be an accurate representation of the current situation and could affect an appropriate monitoring and evaluation of its interventions.	As outlined in the CPD, technical support to the National Statistics Institute (INE) in the development of a robust statistical system was identified as a key element, and it was included in the CPD as a main line of action (refer to paragraphs 28 and 29). Furthermore, as outlined in the CPD - output 5.1 – State will have its capacity strengthened to generate data and evidence generation, that will inform the design of public policies, programmes and budgets focused on children. UNICEF will continue to advocate and engage with the Government to use the available tools and practices, such as the Multi Indicators Cluster Surveys (MICS), Census, and others
