Evaluation of the UNICEF Level 3 response to the global coronavirus disease 2019 (COVID-19) pandemic, and management response

The evaluation focuses on the UNICEF response to the COVID-19 pandemic between January 2020 and March 2022. The learning-focused exercise built on a large body of primary and secondary evidence and yielded a strategically and operationally relevant synthesis for immediate fruition by policymakers and field responders. The report sheds light on how UNICEF operationalized it first global Level 3 activation and measures the extent to which UNICEF was well prepared to respond to the pandemic, including how effectively UNICEF addressed the needs of the affected population and set up successful partnerships at the global, regional and country levels.
