# AGREE

## RECOMMENDATION 1: Contextualize the global theory of change

### ACTIONS:

- Country offices adapt theory of change to consider specific populations of at-risk girls and the potential of scaling up interventions.

## RECOMMENDATION 2: Make Programme agile and adaptative to context variation

### ACTIONS:

- Develop, adapt and roll out tools on the humanitarian-development peace nexus to child marriage and guide strategic phased implementation.

## RECOMMENDATION 3: Strengthen the gender- transformative approaches

### ACTIONS:

- Broaden gender-transformative methods, integrating standard measures in all country programme plans.
- Develop and deploy tools for community-led networks in positive masculinities programming.
- Monitor, evaluate and strategize to address gaps and conflicts in laws and law enforcement impacting child marriage prevention and response at various levels.

## RECOMMENDATION 4: Accelerate the elimination of child marriage globally

### ACTIONS:

- Country and regional offices develop and start using investment cases in national advocacy to influence decisions, catalyse investments.
- Develop a concept note, application toolkit and assessment criteria, and invite potential country offices to position as additional Global Programme countries.
- Develop advocacy briefs with key messages on why prevention and response to child marriage should be prioritized, including in humanitarian action.

# PARTIALLY AGREE

## RECOMMENDATION 5:

Strengthen coordination, partner capacity, resource mobilization, and flexible use of funds

## JUSTIFICATION:

- UNICEF has dedicated staff at country, regional and global levels with expertise in gender and adolescent-youth programming who work on the Programme.
- UNICEF procedures support flexible adaptation of workplans and allocation of programme resources.

## ACTION:

- Country offices develop and implement resource mobilization plans specific to prevention and response to child marriage.
- Develop and deliver a capacity-building model to build grass-roots, youth-led and women-led feminist groups, coalitions and movements to enable them to achieve greater organizational independence, autonomy and resource mobilization to participate.

# AGREE

## RECOMMENDATION 6:

Generate evidence on what works in programme contexts

### ACTIONS:

- Monitor, assess and review the quality of research and evidence generated by regional and country offices, including mechanisms for collecting disaggregated data, outcome measurement and promotion of learning.
- Expand the uptake of evidence and research and the Child Marriage Research to Action Network in partnership with Girls Not Brides.

## RECOMMENDATION 7:

Integrate with social protection sector and advance public financing

### ACTIONS:

- Country offices start mapping social protection programmes and other financing mechanisms; identify potential entry points and advocate to leverage them for girls' empowerment.

## RECOMMENDATION 8:

Elaborate sustainability plans in each country

### ACTIONS:

- Country offices develop and implement institutionalization and sustainability plans.
- Develop a brief on key considerations for sustainability, institutionalization and scalability, including mechanisms for monitoring.
