STATEMENT DELIVERED BY H. E. MR. LAMIN DIBBA, AMBASSADOR AND PERMANENT REPRESENTATIVE OF THE GAMBIA AT THE ANNUAL MEETING OF THE EXECUTIVE BOARD OF THE UNITED NATIONS CHILDREN'S FUND (UNICEF) ON THE ADOPTION OF THE GAMBIA COUNTRY PROGRAMME DOCUMENT (CPD) 2024 – 2028, IN FEBURUARY 2024

Madam Executive Director,
Distinguished Delegates,
Ladies and Gentlemen,

At the outset, allow me to congratulate you and members of your bureau on your election to steer the affairs of the Executive Board of UNICEF for the next one year. You can count on the unwavering support of my delegation throughout your tenure. We also take this opportunity to sincerely thank the leadership of UNICEF at the headquarters, regional and country levels for their steadfast support and strategic guidance in putting together the new Gambia Country Programme Document 2024 – 2028. Its lucid presentation here today is very much appreciated. We therefore endorse the CPD as we look forward to its favorable consideration and approval by the Board.

Let me highlight the key priorities of this document that mirror our own priorities in our quest for greater international solidarity and partnership towards their attainment:

- 1. Every child survives and thrives.
- 2. Every child learns and develops.
- 3. Every child is protected from violence, exploitation and harmful practices and has a legal identity.
- 4. Every child lives free from poverty.

We look forward to working collaboratively with UNICEF toward the successful implementation of the CPD and its priorities, including more advocacy and resource mobilization in the coming years. UNICEF is a trusted development partner that plays a key role in our national development efforts. This new CPD will, therefore, make a significant contribution to the promotion of children's rights and general well-being during the programme period and beyond. We are confident that the lessons learnt from the implementation of the previous CPD will be put to good use. The Gambia views the approval of the document as a unique opportunity to enhance global partnership and solidarity towards a world fit for children.
