Expert Consultation on Age-Related Public Expenditure and Policies

UNICEF Innocenti – Global Office of Research and Foresight (Florence, Italy) 12-13 April 2023

Summary

The purpose of the consultation is to develop a shared understanding of a conceptual and analytical framework, and a basic set of comparable data that countries should collect, to monitor public policies and public finance for children, including both domestic expenditures and foreign assistance, with a focus on what data and research would be of most use to policymakers.

The datasets derived from this data will not be restricted to existing models, but will seek to develop greater granularity suitable for understanding in finer detail the type, timing, amounts and coverage of public expenditures on children, as well as key policies for children behind these expenditures. Expert participants are invited to freely contribute experience, opinion, and evidence to each discussion in regard to conceptual and methodological issues of achieving this goal.

The consultation will be made up of six sessions, presented over a day and a half, and culminate in recommendations for priority actions for children, data collection, and an associated collaborative research agenda. The expert consultation will take place at the offices of UNICEF Innocenti in Florence, Italy.

Existing cross-national datasets of public expenditures on children in the developing world are partial in terms of country coverage, and do not follow best-practice examples seen for high-income settings. The dependence on existing data means that the conceptualisation and monitoring of public finance for children is limited, and broadly unsuitable for the increasing demands of practitioners, donors, researchers, and policy makers seeking to improve the strength of social systems in low- and middle-income countries.

Following a review of current state of evidence of age-related spending on children, and key considerations for delivering on a portfolio of Universal Social Protection policies for children, on the first day, the consultation will address the availability and quality of both family and child policy descriptions and expenditure data on the second day. The meeting will then move to discuss issues for prioritisation and concerted action among participants. The final session of the meeting will seek to develop an agreed position on how to address existing challenges in the availability of necessary evidence for government and development partners working with children, and a position on a more impactful balance of expenditures by type across the lifecourse.
